# 1. OPENING MESSAGE

After having confirmed the quorum, Régine Laurent, President of the Federation, accompanied by Line Larocque, 1<sup>st</sup> Vice-President, Political Officer for the Status of Women and Sociopolitical Sectors, Daniel Gilbert, 2<sup>nd</sup> Vice-President, Joint Political Officer for the Negotiation, Labour Relations and Research Sectors, Claude Boucher, 3<sup>rd</sup> Vice-President, Political Officer for the Education-Animation Service and Joint Political Officer for the Union Organizing Service, Nancy Bédard, 4<sup>th</sup> Vice-President, Joint Political Officer for the Task and Organization of Work Sector and Joint Political Officer for the Negotiation Sector, Linda Bouchard, 5<sup>th</sup> Vice-President, Joint Political Officer for the Labour Relations and Research Sectors, the Legal Team and Joint Political Officer for the Union Organizing Service, Marie-Claude Ouellet, Secretary, Political Officer for the Organization and follow-up of meetings, the action plan and the priority actions, Translation, the Youth Committee and the General Secretariat and Roberto Bomba, Treasurer, Political Officer for the treasury, the Union Defence Fund (FDS), Solidarity, the Information Technology-Documentation Service, Internal and Administrative Services and Human Resources, opened the Special Convention at 11:02.

First, Ms. Laurent welcomed the new delegates for whom this first decision-making body marks their arrival at the FIQ. The members that they represent do not necessarily share the same enthusiasm for being unionized with the Federation, a situation that Ms. Laurent feels is normal and will change with time. In this respect, the FIQ is counting on them as ambassadors to help build trust within their institutions, and also hopes that they will help to better the organization's ways of doing things.

Ms. Laurent continued by pointing out that the next two days will be devoted to the adoption of amendments of the Constitution and Bylaws of the FIQ. These changes are necessary following the reorganization of the Federation, in connection with the passing of Bill 10. This file, very important for the organization, is not the most exciting and requires a lot of attention. Efforts will be made to make it as easy as possible.

She pointed out that since the last Federal Council, many of the current files have kept the organization active. First of all, the Québec Government budget; a budget which, in terms of public perception, was well received. However, it was a budget for garnering votes including several gifts made on the back of the health network. There will no doubt be more money for health, but in examining the details, we find that there will again be cutbacks. Furthermore, in several regions of Québec, many have continued to denounce the impacts of the cutbacks in health and the unacceptable situations that many members and patients are experiencing.

Another topic that has attracted attention is without a doubt the media announcement that the Federation now represents 75,000 nursing and cardiorespiratory healthcare professionals, the great majority of the nurses, licensed practical nurses, respiratory therapists and clinical perfusionists working in the Québec public institutions. According to the media, the FIQ and Alliance du personnel professionnel et technique de la santé et des services sociaux (APTS) were the big winners in the raiding period. They also mentioned the fact that the healthcare professionals identify with the solution-based unionism practised by the FIQ. These findings demonstrate that over the last few years, good choices have been made, choices for the future.

She continued by mentioning that the 40<sup>th</sup> anniversary of the creation of the *Intersyndicale des femmes*, an organization where the FIQ is very active, was celebrated last April. The *Intersyndicale des femmes* has always kept themselves above the fray in the struggles between unions.

The month of May being devoted to the recognition of the healthcare professionals' key role, Ms. Laurent pointed out that once again this year, activities were organized for Health Month to acknowledge the exceptional work of the healthcare professionals of the FIQ. Throughout the year, the latter suffer the poor decisions of the employers. So, these activities are a nice pat on the back for them.

Ms. Laurent continued by referring to several media activities denouncing a secret agreement between the Minister of Health, Gaétan Barrette, and the *Fédération des médecins omnipraticiens du Québec*. Indeed, the minister will allow the physicians in the super clinics to hire healthcare professionals outside of the CISSSs and CIUSSSs. Without any consultation, money intended for public services will now subsidize private entrepreneurs, owners of for-profit entities, thereby depriving healthcare professionals of job opportunities. This decision is full of consequences and the FIQ will continue to denounce it and demand that it be made public.

The president then asked the union representatives to take a look at the internal environment. This meeting is the last one before the regular Convention in November and there is a lot of work to do before then. Among other things, the local negotiations with all the challenges that they represent, setting up the negotiating committees, consulting the members despite the distances, welcoming the new members, and all of this while continuing to resolve the daily problems. To that is added the setting up of the offer of services and, for many, elections of the executives committees.

Faced with the amount of work that this represents, an important condition exists for accomplishing it, that of staying focused on the needs of the members. According to her, personal interests, old grudges and clan rivalries have to be put aside, with the goal of serving the members and, above all, not giving the employers the slightest weakness to exploit.

Furthermore, the members of the Provincial Executive Committee have the same duties. As leaders of the organization, they will therefore be present in the field to accomplish their political work. They are also responsible for taking the best decisions on finances and human resources management. These decisions are always taken with the goal of maintaining the best consulting services and ensuring the financial health of the Federation.

Since the last few months were full of changes and adjustments for everyone, including the employees of the FIQ, Ms. Laurent wanted to point out their prominent place in the organization. Their contribution and the consulting role that they have with the unions and the Executive Committee of the FIQ are key. She thanked them for supporting the organization during all these changes.

At the 11<sup>th</sup> Convention of the Federation this November, the union representatives will have an important task to accomplish, the election of the members of the different committees, including the Executive Committee. It is with a lot of emotion that Ms. Laurent announced that she will not be seeking another mandate as president of the FIQ also announcing at the same time that four other members of the Executive Committee have decided to bow out. They are Line Larocque, Claude Boucher, Linda Bouchard and Daniel Gilbert.

Her primary concern is always to ensure that there is a strong succession for this position, and today, she is certain that this succession is present and ready to take over the reins of this marvellous labour organization. "The strong position in which the FIQ finds itself, along with the presence of an excellent succession, tells me that this is the ideal time to pass the torch", she stated.

From now until the November Convention, she will be preparing a transition that will make the organization even stronger. With this in mind, she said that the whole Executive Committee has decided to unanimously support the candidacy of the current 4<sup>th</sup> vice-president, Ms. Nancy Bédard, who they feel is well prepared and the ideal person to assume these duties. However, she pointed out that this support of the Executive Committee is in no way questioning the democratic right of someone else to submit their candidacy or their right to vote for whomever they want.

Ms. Laurent concluded by stating that taking on the role of the president of the FIQ has proven to be one of life's greatest gifts. Reiterating that she hasn't left yet, she will still pursue her work until the next Convention with the same enthusiasm and energy. Until then, there is a lot of work to do, starting with the four days this week.

She wished everyone good debates!

# Questions of privilege:

- Ms. Manon Larochelle, delegate from the CISSS de Chaudière-Appalaches and member of the Education-Animation Committee, informed the delegates that a karaoke evening is organized at the end of the debates on Thursday. She invited the members of the CISSSs, CIUSSSs and the other institutions to register as a team for this activity which will be a friendly competition. Lastly, she gave the registration instructions which will start after lunch at the booth set up for this purpose.

- Ms. Lyne Plante, delegate from the CISSS de l'Outaouais, stated that the Regional Action and Consensus-Building Table (TRAC) of Outaouais will participate, for a 5<sup>th</sup> consecutive year, in the *La nuit des sans-abri (Night of the Homeless)* which takes place this October. As a gesture of solidarity for this cause, she asked for the collaboration of the delegates in bringing all the personal hygiene products in their rooms so that they can be distributed to the homeless during this event. A designated box to collect these items will be placed in the back of the meeting room as of Wednesday.

- Ms. Marie-Claude Ouellet, Executive Committee FIQ, reminded the delegation that the Federation is a democratic organization which, through its structure, has always promoted the involvement of the greatest number possible of members in decision-making, thus giving the delegates attending the various meetings the time to speak. However, it has been brought to the attention of the Executive Committee that, over the last few years, some members have been intimidated following their interventions at the microphone. Ms. Ouellet informed the delegates that the Executive Committee can no longer tolerate such behaviour. She reiterated that the instructions from the chairperson must be respected and that all the union representatives are entitled to their opinions and must be able to express those opinions freely in the different debates.

# 4. ADOPTION OF THE RECOMMENDATIONS IN DOCUMENT D8 OF THE FEDERAL COUNCIL OF MARCH 21, 22 AND 23, 2017

#### Presented by: Ms. Marie-Claude Ouellet, Political Officer.

Ms. Marie-Claude Ouellet reminded the delegation that, at the Federal Council of last March, it adopted a motion that recommended to the Convention to withdraw from the FIQ Orientations 2015 the mention of a 4<sup>th</sup> decision-making level, the Council of Regions and regional vice-presidents, as well as the amendments of the Constitution and Bylaws of the FIQ concerning the Executive Committee of the FIQ, in order to keep the status quo.

In order to proceed now with the adoption of the amendments of the Constitution and Bylaws of the FIQ, motion **A17-CE-II-03** (recommendation 1 in document D2) (Ouellet-Laurent) was tabled.

A 15-minute plenary session began. A short deliberative assembly began and then the Chair called for the vote.

# 5. CONSTITUTION AND BYLAWS OF THE FIQ

#### 5.1 Amendments of the Constitution and Bylaws of the FIQ

**Presented by:** Ms. Marie-Claude Ouellet, Political Officer, accompanied by Ms. Michelle Poirier, Coordinator, and Mr. Louis Jolicoeur, Union Consultant.

**Reference documents: A17-CE-II-D3** "Amendments to the FIQ Constitution and Bylaws" and **A17-CE-II-D4A** "Appendix: Hypotheses on the delegation – disaggregated data, *Regroupement des FIQ*". **A PowerPoint accompanied the presentation.** 

In terms of functioning, the Chair gave explained how the presentation would be given on the adoption of the amendments to the Constitution and Bylaws of the FIQ. She stated that document D3 will be divided into four blocks, each block followed by a deliberative assembly:

- Block 1 Chapters I and III, vote levels 1 to 16
- Block 2 Chapters IV and V, vote levels 17 to 39
- Block 3 Chapters VI, VII, VIII and IX, vote levels 40 to 60
- Block 4 Chapters X, XI, XII and XIV, vote levels 63 to 88

Before beginning the adoption of the amendments to the Constitution and Bylaws of the FIQ and *Regroupement des FIQ* (RFIQ), Ms. Marie-Claude Ouellet wanted to point out that setting up the *Regroupement des FIQ* meets the recommendation adopted at the Special Convention of March 21, 2017 on the creation of a new labour organization in health. This new federation will combine the FIQ and *FIQ* | *Secteur privé* (FIQP) and coexist within the same entity.

To have an overall view of the new organization, Ms. Ouellet presented the PowerPoint which puts into perspective the decision-making structure of the three federations and the powers they would have so that they can fully carry out their roles.

A 15- minute plenary session began after the presentation.

Ms. Ouellet presented the amendments proposed by the Executive Committee and appearing in document D3 and explained some of them.

A 30-minute plenary session began on the entire document D3.

# PROVINCIAL EXECUTIVE COMMITTEE

The Provincial Executive Committee assumes the planning, administration and control of the Federation. It ensures follow-up on the debates, activities and mandates. It takes stands on all questions in line with the orientations of the organization and in the collective interest.

It encourages, in collaboration with the presidents of the affiliated unions, the presence and influence of the *Regroupement des FIQ* in the regions. Lastly, it ensures consistency in union action in the implementation of the action plans.

# ARTICLE 1- POWERS

The Provincial Executive Committee has the following powers:

- 1. To execute the decisions of the Provincial Convention and the Provincial Council;
- 2. To ensure the political representations of the Federation;
- 3. To prepare the action plans based on the decisions of the Provincial Convention and the Provincial Council;
- 4. To formulate recommendations to the Provincial Convention and the Provincial Council;
- 5. To set up the committees that it deems necessary and appoint the members;
- 6. To ensure that the constitution, bylaws and operating protocol are respected;
- 7. To establish the general policies and submit them to the Provincial Council;
- 8. To decide to hold a Provincial Council, a Special Provincial Council, a Provincial Convention or a Special Provincial Convention;
- 9. To recommend that the Provincial Council turn into nurse, licensed practical nurse, respiratory therapist and clinical perfusionist commissions;
- 10. To promote and encourage solidarity and mobilization between the federations and their affiliated unions;
- 11. To encourage the pooling of regional realities and to circulate the main findings;
- 12. To ensure and contribute to the consultation of the affiliated unions on set subjects;
- 13. To study any issue submitted by the Provincial Convention, Provincial Council and the executive committees of the federations;
- 14. To receive the activities reports from the provincial committees and the sectors and services of the FIQ;
- 15. To give a report on its activities to the Provincial Convention;
- 16. To monitor the use of the Union Defence Fund and administer the equalization system.

# ARTICLE 2- COMPOSITION

The Provincial Executive Committee is composed of eleven (11) people, the nine (9) members of the Executive Committee of the FIQ and of two members of the Executive Committee of the FIQP, including the president or her replacement during an extended absence.

# ARTICLE 3- SITTING OF THE PROVINCIAL EXECUTIVE COMMITTEE

The Provincial Executive Committee meets at least four (4) times a year.

The meetings of the Provincial Executive Committee are convened by the secretary, upon the request of the president or of three (3) of its members, with a notice of at least ten (10) days. This notice must specify the agenda for the meeting to the extent possible.

The agenda of the Provincial Executive Committee is prepared by the secretary.

In the event of an emergency, the notice can be sent by email, telephone or fax at least twenty-four (24) hours before the meeting, such a notice being sufficient in these circumstances.

A member of the Provincial Executive Committee can waive the previously mentioned notice at any time.

# ARTICLE 4- QUORUM

The quorum is six (6) people, including at least one (1) person from the Executive Committee of the FIQP.

# ARTICLE 5- VOTE

Each member of the Provincial Executive Committee has one vote. In the case of a tie vote, the president has the deciding vote.
