**MINUTES OF THE SPECIAL CONVENTION OF THE  
FÉDÉRATION INTERPROFESSIONNELLE DE LA SANTÉ DU QUÉBEC  
HELD ON MARCH 13, 2015 AT CENTRE DE CONGRÈS ET D'EXPOSITION IN  
LÉVIS**

**FRIDAY, MARCH 13, 2015**

The delegation listened to a short radio extract from Mr. Jean Lapierre, Journalist at 98.5 FM who was commenting positively on the March 12 demonstration held in front of the National Assembly.

Then, Ms Laurent invited the delegation to read the article published in « *Le Soleil* » newspaper about the interview on retirement done jointly with Daniel Gilbert. And, she stated that the demonstration yesterday was a good return on the investment.

**1. OPENING MESSAGE FROM THE PRESIDENT**

After having confirmed the quorum, Régine Laurent, President of the Federation, accompanied by Line Larocque, 1st Vice-President, Political Officer for the Status of Women and Sociopolitical Sectors, Daniel Gilbert, 2nd Vice-President, Joint Political Officer for the Negotiation, Labour Relations and Research Sectors, Claude Boucher, 3rd Vice-President, Political Officer for the Education-Animation Service and Joint Political Officer for the Union Organizing Service, Nancy Bédard, 4th Vice-President, Joint Political Officer for the Task and Organization of Work Sector and Joint Political Officer for the Negotiation Sector, Linda Bouchard, 5th Vice-President, Joint Political Officer for the Labour Relations and Research Sector, Michel Mailhot, 6th Vice-President, Political Officer for the Social Security, Occupational Health and Safety Sectors, the Legal Team and Joint Political Officer for the Union Organizing Service, Marie-Claude Ouellet, Secretary, Political Officer for the Organization and follow-up of meetings, the action plan and the priority actions, Translation, the Youth Committee and the General Secretariat and Roberto Bomba, Treasurer, Political Officer for the treasury, the Union Defence Fund (FDS), Solidarity, the Information Technology-Documentation Service, Human Resources and Administration Services, opened the Special Convention at 09:00 am.

Ms Laurent stated that the delegation will have the opportunity to learn about the FIQ 2015 orientations and to decide on the motions to amend the Constitution and Bylaws. Once the decisions are taken by the Convention, the work can continue in particular on the Constitution and Bylaws.

She concluded by wishing everyone good debates.

Martine Caron acted as chairperson and read the agenda. She stated that since this is a Special Convention and therefore no additions or changes can be made to the agenda.

## **4. FIQ 2015 ORIENTATION PROJECT**

**Presented by:** Marie-Claude Ouellet, Political Officer for the action plan and the priority actions and Michel Mailhot, Joint Political Officer for the Union Organizing Service, accompanied by Michelle Poirier, Union Consultant.

**Reference document:** A15-CE-I-D2 "FIQ 2015 orientations".

In terms of functioning, the Chair stated that Document D2 will be divided into two blocks each one being followed by a plenary session. Then, there will be a deliberative assembly, then the vote on the entire Document D2.

Ms Ouellet began by recalling that at the Federal Council of January last, the delegates adopted recommendations aimed at adjusting the structures of the Federation and of its unions to the regionalization of the Health and Social Services Network orchestrated by Bill 10 which will go into effect on April 1.

Concerned with offering services close to the members and maintaining the union representatives' commitment, the FIQ is proposing that each union affiliated with the FIQ set up operating models which promote close-at-hand services and the expression of a real power at the different decision-making levels.

### **BLOCK 1 - The composition of the FIQ Networks (Women, Youth, OHS)**

It is pertinent to maintain the composition of the FIQ Networks (Women, Youth and OHS) during the transition of the CSSSs into CISSSs and CIUSSSs. The composition of the FIQ Networks just like the composition of the delegation to decision-making bodies, is based on the number of members in each one of the CSSSs or institutions, the same as on the number of sites that make up the CSSS. It is important to preserve these networks during the transition of the CSSSs into CISSSs and CIUSSSs.

However, the composition of the FIQ Networks also provides for the participation of a union representative from every regional action and consensus-building tables (TRAC). Considering the upcoming creation of the CISSSs and the CIUSSSs and their impacts on the TRAC, it must be planned that this union representative will cease participating at the time the TRAC in her region is dissolved.

Considering the passing of Bill 10 (Act modifying the organization and the governance of the health and social services network, particularly by abolishing the regional agencies) and its going into effect soon. It is fitting to preserve the stability and the consistency of the union and political action of the FIQ during this period. The Executive Committee is recommending a transitional measure regarding the delegation to FIQ decision-making bodies and the participation of the union representatives in the decision-making bodies of the Federation and to Network meetings. Michel Mailhot tabled motion **A15-CE-I-06** (Ouellet-Mailhot).

A 20-minute plenary session began.

#### **Question of privilege**

Sophie Séguin, delegate, asked the chairperson to vote on recommendation 2 before recommendation 1 in Document D2.

#### **BLOCK 2 – The foundations for the setting up of the Council of Regions and the vice-presidents**

Last January, the Executive Committee shared its reflection with the delegation on the necessity of the FIQ having a fourth level in the decision-making structure in the context of the regionalization of the health and social services network. Indeed, a FIQ regional structure makes it possible for the Federation to get closer to its members, in a very concrete way.

##### ► Council of Regions

The Council of Regions will be a consultative and decision-making body and will be composed of 6 members of the Executive Committee of the Federation and 6 regional vice-presidents elected by the Convention. The powers of the Council of Regions will be to:

- Promote and encourage solidarity and mobilization among the affiliated unions;
- Execute the mandate given to it by the Convention, the Federal Council and the Executive Committee of the Federation;
- Study all questions submitted by the Federal Council and the Executive Committee of the Federation;
- Receive the reports on the activities of the federal committees and the sectors and services;
- Give a report on its activities to the Convention;
- Formulate recommendations to the Convention and the Federal Council;
- Favoriser la diffusion et la mise en commun des réalités régionales;
- Collaborate with the Executive Committee of the Federation in the preparation of action plans and participate in their implementation;
- Ensure and contribute to the consultation of the affiliated unions on the subjects determined by the Executive Committee of the Federation;
- Monitor the use of the Union Defence Fund and the application of the system of equalization;
- Recommend the transformation of a Federal Council into nurse, licensed practical nurse, respiratory therapist and perfusionist commissions;
- Set up the committees that if deems necessary and appoint the members.

##### ► The regional vice-presidents

The regional vice-presidents will be elected by the Convention. Each vice-president comes from an institution in the region or from the regions for which she has responsibility. She will be the regional FIQ spokesperson. Her responsibilities will be to:

- Participate in the organization of regional union life, support the battles and the interventions of the affiliated unions;
- Contribute to achieving the activities of the FIQ in the region;
- Ensure an ongoing link between the Executive Committee of the Federation and the region;
- Assume the political representations of the FIQ at the regional level;
- Know the socio-economic and political portrait of her region;
- Know the specificities of the affiliated unions in her region;
- Collaborate with the affiliated unions in adapting the action plans to the characteristics of the region;
- Execute any mandate given to her by the Executive Committee of the Federation.

Marie-Claude Ouellet presented the impacts of the integration of the Council of Regions on the current Constitution and Bylaws.

Michel Mailhot tabled motion **A15-CE-I-11** (Ouellet-Mailhot).

A 90-minute plenary session began.

Motions **A15-CE-I-07** (Wong-Plante); **A15-CE-I-08** (Paul-Plante); **A15-CE-I-09** (Gilardeau-Morel); **A15-CE-I-05** (Séguin-Lamothe); **A15-CE-I-03** (Beaulieu-Boulanger); **A15-CE-I-04** (Fridi-Schnob) and **A15-CE-I-10** (Gilardeau-Morel) were tabled.

In terms of functioning, the motion **A15-CE-I-03** for an in camera meeting will be dealt with first.

A plenary session exclusively for this motion began. There being no questions or comments, the chair called the vote.

The plenary session continued.

Following the comments expressed, Michel Mailhot clarified that the delegation seems to be in agreement with the distribution of powers. The comments have all been noted and they will enable the committee to continue its work. There is a lot of work to do to organize and structure things and to carry out a reflection on the budget.

A 45-minute deliberative assembly began.

## **5. CONSTITUTION AND BYLAWS**

### **5.1 Amendments to the Constitution and Bylaws**

**Presented by:** Marie-Claude Ouellet, Political Officer for the action plan and the action priorities.  
**Reference document:** A15-CE-I-D3 "Constitution and Bylaws: Motion to amend".

Document D3 was already presented at the last Federal Council and the Executive Committee proposed maintaining the current composition of the delegation to FIQ decision-making bodies until the next Convention, and this, according to the current conditions in the FIQ Constitution and Bylaws. Therefore, the delegation would be set using the April 1, 2014 lists considering that with the merger of the institutions on April 1, 2015, we still do not know how the list of members of the future CISSSs and CIUSSSs will be sent to the FIQ.

A 15-minute plenary session began. There were no comments or questions.

A deliberative assembly began followed by the call to vote.

**A15-CE-I-12**

**BE IT MOVED:**

Recommendation 1 of Document D8

"Modifying the FIQ Constitution and Bylaws in order to add to CHAPTER XV – MISCELLANEOUS PROVISIONS, the following text:

#### **ARTICLE 3 – TRANSITIONAL MEASURE**

Articles 3, 4, 5 and 6 in Chapters IV – CONVENTION and V – FEDERAL COUNCIL remain in effect.

Notwithstanding the above, the composition of the delegation stipulated in articles 3 of Chapters IV – CONVENTION and V – FEDERAL COUNCIL is that known on March 31, 2015 and remains in effect until the next orientation convention of the FIQ in 2017 or until a future convention decides otherwise.

In addition, the secretary of the FIQ will determine the delegation of the new members based on the list of employees on April 1, 2014."

## **6. CLOSING REMARKS**

Régine Laurent, accompanied by the members of the Executive Committee, asked the delegates to invite their members to attend the Advocacy training session. The members of the Executive Committee, the consultants in the Task and Organization of Work Sector and the Education-Animation Service are already certified by the *Université de Sherbrooke*. The FIQ is making this shift to be able to respond to the members' needs, even if it is not the primary mission of the organization. Thus, the healthcare professionals will be better equipped to advocate for their patients.

The analysis of the context is an essential step in the negotiating process. The context being in constant evolution, she demanded heightened vigilance in order to fully understand the effects on the negotiations and the members of the FIQ. In this respect, Ms Laurent asked the delegation to learn more about the next budget from the Minister of Finance, Mr. Carlos Leitao. We must rely on our communication and mobilization strategy, as it has shown results.

Following the adoption of the recommendations on adjusting the structures of the FIQ and those of its affiliated unions to the regionalization of the Health and Social Services Network orchestrated by Bill 10, the focus group on the Constitution and Bylaws as well as the team working on the connections with the affiliated unions and the financial management of the transition will begin to accelerate their work. Ms Laurent stated that the decisions taken by these focus groups will be the subject of discussion in a decision-making body.

In conclusion, Ms Laurent has high hopes that all the decisions which will be taken in the future will be the best and will enable the FIQ to progress. On that, she wished the delegation a safe return trip.
