The Charest government wants to make a lot of room for the private sector in the health-care network. The decision to close the *CHSLD Jacques-Viger* in Montreal is another good example of State disinvolvement. Mobilisation against this decision began and several actions have already been organized. On October 9, during a press conference, the spokespersons for the FIQ and the CSN jointly denounced the decision to reduce the number of beds in CHSLDs. Quebec table on the workforce planning project for the health and social services network

On September 27, the FIQ took part in this consensusbuilding table where it argued that it was urgent to find solutions and take action to face up to the situation of workforce shortage. A Quebec workforce planning project will be presented to the MSSS authorities by March 31 coming.

Bouchard-Taylor Commission

The inquiry on the place of religion in the public space aroused keen interest among FIQ members and the response rate was 25%. The compilation of the questionnaires and responses received is under way, and the results which will enrich the FIQ's positions will be analyzed during the fall.

In addition to finalizing its work with the Commission des droits de la personne et des droits de la jeunesse (CDPDJ), the FIQ closely follows the hearings of the Consultation Commission on Accommodation Practices Related to Cultural Differences (CCPARDC), co-chaired by the sociologist and historian Gérard Bouchard and the philosopher Charles Taylor.
