On July 16, the FIQ and the Canadian Federation of Nurses Unions (CFNU) jointly organized a day of reflection in Quebec City, attended by over 75 experts from different regions of Canada. The purpose of this meeting was to establish the key considerations to submit to the Premiers, who were meeting the same week in Quebec City at the Council of the Federation, to remind them that health care remains a priority for Canadians.

September 28 : Canada-wide demonstration against Bill C-484



Bill C-484, The Unborn Victims of Crime Act, which opens the door to the recriminalization of abortion turning the clock back 20 years on women's rights, has generated strong opposition by many organizations, including the Fédération du Québec pour le planning des naissances, the Fédération des femmes du Québec, as well as the Quebec Bar and the Fédération des médecins spécialistes du Québec. In an opinion addressed to the Chair of the Standing Committee on Justice and Human Rights, the Quebec Bar clearly explains the dangers of this bill.
