

## **Quebec Parliament resumes The SISP issues orientations**

On March 9th, on the eve of the reopening of Parliament, the union leaders of the Secrétariat intersyndical des services publics (SISP), including the FIQ president, made public an important statement in response to the financial crisis, which has become an economic crisis and a social justice crisis. This statement, entitled, De la parole aux gestes, contains clear and essential orientations for putting Quebec back on track. The SISP demands that the Quebec government focus its efforts on sustainable development, sharing of the collective wealth and improving access to quality public services. The demands on the next Parliamentary session address six domains of intervention.

### Meeting with Minister Bolduc Insufficient guarantees



health care system. Following this meeting, the SISP therefore filed, in Superior Court, a motion to quash in order to have the Regulation respecting the specialized medical treatments provided in specialized medical centers declared illegal. The Regulation covered by the motion allows about fifty additional surgeries to be performed in private specialized medical centers besides the hip, knee and cataract surgeries already approved. For the SISP, this regulation goes beyond what is permitted by the Act respecting health services and social services as well as by Bill 33. Filing this motion is aimed at pressuring the Quebec government to stop the legalization of the private sector.

# Closing of the Commission on the Status of Women at the UNO

Since the opening of the 53<sup>rd</sup> session of the Commission on the Status of Women (CSW) at the UNO, the member States and the non governmental organizations present at the meetings worked relentlessly to put forward amendments to the proposed conclusions, so that, in some cases, they better protect women's rights to equality and, in other cases, to limit their obligations on this subject. After two weeks of debates and intensive lobbying, the agreed upon conclusions were passed by consensus on March 13th. Thanks, in large part, to societal pressures these conclusions offer the women's movement and social organizations a tool to force governments to respect their obligations in respect to the sharing of responsibilities between men and women.
