



# The Tackle Tax Havens group campaign

The Groupe Échec aux paradis fiscaux (Tackle Tax Havens Group), in which the FIQ takes part, launched its "Levez le voile sur les paradis fiscaux!" (Unveil tax havens!) campaign on April 29. They have also joined the Canadian movement launched by the Canadians for Tax PARADIS FISCAL Fairness group to demand that the Canadian and Quebec governments publish official estimates of the amounts out of the reach of the public treasury because of the tax havens used by big business and the wealthy taxpayers from here.



The public is invited, in the context of this campaign, to go to the www.echecparadisfiscaux.ca website to send a message to the Ministers of Finance for Québec and Canada, Nicolas Marceau and Jim Flaherty, to the Minister of National Revenue, Gail Shea, as well as to their MNAs. In addition to this campaign inviting the public to apply pressure on the governments, the Tackle Tax Havens Group will continue its work in order to claim more vigorous actions against the use of tax havens from the governments over the coming months.
