The Federation will do an in-depth analysis of this project and intends to take a good look at the issues raised by the creation of an insurance and an autonomy fund in the health network.

The FIQ wants to participate in the upcoming consultations in order to ensure that what is proposed in the White Paper takes into account the real needs of all people with loss of autonomy and that they are given quality and accessible care.

The FIQ asks the Senate to cancel Bill C-377

On May 30, Michel Mailhot, 6th Vice-President, and Michel Canuel, Union Consultant on the FIQ legal team, appealed Bill C-377 before the Standing Senate Committee on Banking, Trade and Commerce, this bill being An Act to Amend the Income Tax Act. This bill, if passed, will force the labour organizations to publish their financial statements. The FIQ is strongly opposed to this antiunion bill that aims to undermine the bargaining power of unions. The members of the Federation can find out exactly how their union dues are used and the audited financial statements are available and are distributed to the delegates at Federal Councils.

The Federation considers this bill legally invalid, because its purpose is not intended to have income taxes paid on income, but the certification of workers which is under provincial jurisdiction and civil rights. The representatives from the FIQ asked the Senate Committee to reject Bill C-377 or to systematically amend it so that it only covers fiscal matters.
