But the authors observed how managers' appreciation has gradually and insidiously been transformed until it has become meaningless for nurses.

Proaction: a placement agency to watch

It is appalling to observe the extent to which business rules are not observed in service contracts between Montréal health network institutions and private placement agencies. The FIQ responded with a press release to the report submitted to the Minister Réjean Hébert, Application des règles d'octroi des contrats à la firme Proaction dans la région de Montréal (Application of contracting rules to Proaction in the Montréal region), which reveals deficiencies in 8 of the 10 contracts examined. The FIQ is calling on the Minister to act quickly and suspend the contracts made with Proaction. This report also shows the laxness of some institutional administrators and the Agence de santé et de services sociaux de Montréal.
