The president of the FIQ went to Ste-Anne-des-Monts on May 16 to meet with the healthcare professionals from the region to discuss the current challenges of the Federation, including the new models of care that it wants to install. Régine Laurent thus met with Sébastien Des Roches, President, and Mylène Alain, Grievance Agent, for the *Syndicat des professionnelles en soins de la Gaspésie* and the members from several institutions in the region.





Ms Laurent also spoke with the physicians during her visit.

Remember that the small homes for seniors and neighbourhood clinics projects that the Federation is currently spearheading aim to allow ailing seniors to remain in their environment rather than going to the major centres, and allow the healthcare professionals to make good use of their full potential. Several members took advantage of Ms Laurent's visit to tell her about the regional problems and their expectations regarding the negotiation of the next collective agreement. They also endorsed the negotiation sectoral priorities targeted by the FIQ as part of the preconsultations.
