Ms Laurent as well as Audrey Blackburn, President of the SPSS Lac-St-Jean-Est, Sandra Chiasson, President of the SPSICR du CSSS

Domaine-du-Roy, Martine Côté, President of the SPSICR du CSSS de Chicoutimi, and Pauline Paradis, President of the SPSICR du CSSS Maria-Chapdelaine, denounced the intolerable working conditions that the healthcare professionals have been confronted with for the last few months. Working in such conditions outright threatens the quality of care and the safety of the patients.
