### The FIQ files its sectoral demands



On November 10, when the Federation's sectoral demands were filed, the delegates meeting at a special federal council in Quebec City, took part in a large-scale demonstration in the streets of the provincial capital.



The activists first accompanied their representatives to the office of the *Comité patronal de négociation du secteur de la santé et des services sociaux* (CPNSSS), where they had an appointment at 11:00 for the official filing. The delegates then diverted to the National Assembly to hear the passionate speech of their president Régine Laurent, but also to notify the government about the difficulties experienced by the healthcare professionals in the public healthcare network. They were able to do it concretely and in an original way by responding, on self-adhesive paper, to the following question: "The healthcare professionals are stuck on the healthcare network. What difficulties do they have?". The numerous papers reflecting each one's

reality were then stuck on the big plastic boards placed in front of the National Assembly. At the heart of the healthcare professionals' concerns: a reduction of the workload and job insecurity, an improvement in the working conditions in a perspective of attraction-retention and the recognition and enhancement of training/education.
