



Retirement: A survey by the FIQ sounds the alarm

On April 12, the Federation publicly disclosed the results of a survey conducted with its members age 50 to 64 to determine the proportion of healthcare professionals intending to retire over the next three years. The objective of this survey was to know the impacts of the changes to their pension plan proposed by the *Conseil du trésor* as part of the current negotiations.

The results of the survey indicate that nearly half the healthcare professionals over age 50 intend to retire in the next three years because of the penalties in the pension plan

that the Government wants to impose. This would mean a massive departure of 7,500 nurses, licensed practical nurses, respiratory therapists and perfusionists.

On April 10, Ms. Laurent, along with Mr. Guy Brochu, President of the CHUM union, personally met with Ms. Durocher to discuss her concerns with her and to answer her questions.
