MINUTES OF THE 1<sup>ST</sup> CONVENTION OF THE FÉDÉRATION INTERPROFESSIONNELLE DE LA SANTÉ DU QUÉBEC | SECTEUR PRIVÉ (FIQP) HELD ON NOVEMBER 29, 2017, AT THE LÉVIS CONVENTION AND EXHIBITION CENTRE.

WEDNESDAY, NOVEMBER 29, 2017

#### 1. OPENING MESSAGE

Sonia Mancier, member of the interim Executive Committee of the FIQ | Secteur privé (FIQP) opened the 1st convention at 4:50 p.m. and addressed the delegation.

The FIQP dreamed big, was bold and trusted in its ability. The new federation will focus on protecting and promoting the needs and demands of healthcare professionals in healthcare settings in private subsidized institutions and private institutions, outside of CISSSs and CIUSSSs. The FIQ is big and the FIQP is agile – the FIQ has range and the FIQP has proximity – the FIQ has great numbers and the FIQP is bold.

And those were the first words written in the pages of the FIQP's great adventure. The members took their destiny into their hands and will be proud of what their organization will accomplish to improve care safety and the population's well-being.

Sonia Mancier gave a thorough reading of document D3.

Following the presentation, motion FIQP-A17-C-I-13 (Mancier-Tremblay) was tabled.

A 20-minute plenary session was held concerning the presentation followed by a deliberation.

Since there were no interventions, the chairperson called a vote.

#### **PREAMBLE**

Whether by its orientations or actions, the Regroupement des FIQ is committed, in the field of labour, social and economic struggles, to promoting a society that recognizes the priority of human rights over economic imperatives and that seeks greater justice and an equitable distribution of wealth and power, without affiliation to any political party.

Hence, the Regroupement des FIQ is committed to upholding and promoting the principles in the Quebec Charter of Human Rights and Freedoms.

#### STATEMENT OF PRINCIPLES

#### THE REGROUPEMENT DES FIQ

The Regroupement des FIQ is a labour organization that works primarily to uphold and promote the economic, social and professional interests of its members.

It strives to be a collective tool for consciousness-raising and advocacy.

#### AN ORGANIZATION THAT IS OPEN AND DEMOCRATIC

The Regroupement des FIQ is a democratic organization which promotes the participation of the largest number of members in decision-making by its structure. It is also committed to ensuring the involvement of women at the different decision-making levels by using the appropriate measures.

Its actions rest on the mobilization of its members and it is therefore committed to ensuring that all its members have access to the same quality of union life by recognizing their right to information, union education and the choice of union structure (local, regional or sectional) as essential conditions to the practice of democracy within its ranks.

#### AN ORGANIZATION DEDICATED TO IMPROVING WORKING CONDITIONS

In the field of negotiations and labour relations, the Regroupement des FIQ while taking into account the specificity of its membership, aims, by its actions, to promote and strongly uphold the right to collective bargaining, and to decent working and living conditions, as well as the right to work in a sound violence-free environment.

#### AN ORGANIZATION FOCUSED ON HEALTH CARE

Key actor in the health sector, the Regroupement des FIQ has a leading responsibility in the debates on the accessibility, universality, free-of-charge nature and quality of healthcare services.

The Regroupement des FIQ participates in the debates on the choices to be made in health services and makes it a point to denounce all sorts of abuse. It is committed, in this respect, to promoting and defending the public's right to health and the right of nursing and cardiorespiratory healthcare professionals to deliver care in an atmosphere of respect and dignity.

#### AN ORGANIZATION THAT PROMOTES WOMEN'S RIGHTS

The Regroupement des FIQ recognizes that a society cannot progress without promoting women's rights. For this reason, it is actively involved, together with other women's groups, in promoting and upholding these rights, and publicly denouncing the iniquities and prejudices suffered by women. More specifically, the Regroupement des FIQ pursues the struggle to counter poverty and violence, a struggle already begun by the international women's movement and is part of a context that threatens the fundamental rights of women.

#### AN ORGANIZATION UNDER THE BANNER OF SOLIDARITY

The Regroupement des FIQ initiates and strengthens solidarity with other labour, feminist and community groups, in accordance with its general orientations, whether at the regional, provincial or international level. It is also committed to reinforcing solidarity among its members.

#### AN ORGANIZATION WHICH RECOGNIZES ITS UNION REPRESENTATIVES

The Regroupement also recognizes the key role of the union representatives in the organization achieving its mission, namely for their invaluable knowledge of the work setting as healthcare professionals. It is committed to supporting and setting up the conditions that will ensure a succession for those who would want to get involved in the organization as elected officers, coordinators or employees.

#### AN ORGANIZATION GRATEFUL FOR AND RESPECTFUL OF EMPLOYEES

The Regroupement des FIQ recognizes the key role of the employees in the organization achieving its mission. It is committed to supporting and promoting the employees actions in a perspective of involvement and activism, at both the union and social level. It is also committed to deploying the necessary means to develop and promote the employees' commitment.

#### 5. FINANCES

#### 5.1 2018 Financial Forecast

**Presented by:** Martine Tremblay and Sonia Mancier, members of the interim Executive Committee of the FIQP.

Reference document: FIQP-A17-C-I-D2 "2018 Financial Forecast."

To begin, Sonia Mancier reminded the delegation that following implementation of Bill 10, the delegation had agreed to reorganize the FIQ upon the introduction of the CISSSs and CIUSSSs. All of the unions had unanimously agreed to participate in the restructuring.

The sense of belonging to the FIQ was so strong that the regional unions that were solely with private institutions and private subsidized institutions expressed their desire to remain with the FIQ. The delegation therefore created the FIQP, an organization that will allow these institutions to maintain their affiliation with the FIQ, establish bargaining power and achieve an important goal: to create a central labour body (recommendation from 2014).

Like all new structures, this one needs financial help to begin the project on the right foot. First, we looked at the possibility of redirecting part of the equalization paid to affiliated unions to the FIQP, but that would weaken the FIQP's already unstable finances and would tarnish member services.

With the exception of private subsidized institutions (EPCs), which benefit from a certain number of subsidized leaves, private institutions get little to no union leaves. When delegates wish to participate in meetings, it's often the union that must absorb the cost of the leaves.

In order to maintain adequate union life in all institutions, it is proposed to not touch the equalization and to transfer the FIQP the equivalent of the overall amount of equalization paid to FIQP affiliated unions: approximately \$147,000.

Martine Tremblay continued the presentation with document D2.

Motion FIQP-A17-C-I-14 (Tremblay-Mancier) was tabled.

A 20-minute plenary session began.

Ms. Mancier specified that adjustments to the financial forecast will be made gradually.

A 10-minute deliberation began.

Ms. Mancier used her right to reply.

The chairperson called a vote.

#### FIQP-A17-C-I-14 BE IT MOVED:

"To adopt the 2018 financial forecast as presented."

1.24% of the 6th echelon of the licensed practical nurses', respiratory therapists' and nurses' salary scales for each dues-paying member. Starting on April 2, 2018, the dues will be 1.24% of the 9th echelon of the nurses' salary scale for nurse job titles."
